The South Dakota Statewide Homeless Management Information System (SDHMIS) is administered by South Dakota Housing Development Authority (SD-500 CoC collaborative applicant). SDHMIS is computerized data collection application designed to capture client level information over time on the characteristics and service needs of homeless persons and families. The development of SDHMIS includes 1) bringing the power of computer technology to the day to day operations to individual homeless assistance providers. 2) knitting together providers and within the state in a coordinated and effective housing and service delivery system for the benefit of homeless clients 3) obtaining and reporting critical aggregate information about the characteristics and needs of homeless persons. 4) providing a source of data for decision making processes. There are currently 13 agencies utilizing HMIS with a total of 46 active users and 20200 client records. Agencies providing services via Runaway Homeless Youth (RHY), Support Services for Veteran Families (SSVF), Health Care for Homeless Veterans (HCHV), Grants Per Diem (GPD), Emergency Solutions Grant (ESG), and Continuum of Care Funded (CoC) are entering into HMIS. Efforts at increasing HMIS coverage are continuing as part of Coordinated Entry System (CES) development. The increase coverage from CES implementation is resulting in additional costs for continued development of software, additional fees associated for adding users, and for the additional data storage needs evident.
