System Performance Measurements (SysPM) FY 2016 – SD, Statewide CoC

- Sys PM Submitted to HUD Homelessness Data exchange; 5/25/17
- For FY 2016 report; 7 measures taken from reports generated from HMIS. Prior data submitted FY 2015 compared to FY 2016 data.
- New for 2016 submission included a SysPM Data Quality tab

System Performance Measurements (SysPM) FY 2016 – SD, Statewide CoC

- SysPM Measures FY 2016 included data submitted measuring:
 1. Length of time persons remain homeless.
 2. The extent to which persons who exit homeless to permanent housing destinations and return to homelessness.
 3. Number of Homeless Persons.
 4. Employment and Income Growth for Homeless Persons in CoC Funded Projects
 5. Number of Persons who become homeless for the first time.
 6. Was not applicable in the FY 2016
 7. Successful placement from Street Outreach and successful placement in or retention of Permanent Housing.

System Performance Measurements (SysPM)

FY 2016 – SD, Statewide CoC

New Data Quality Tab Requirement

- Required creating reports for 5 separate groups of project types for 4 separate years each.

The project types were; Emergency Shelter, Safe Haven, Transitional Housing, Permanent Supportive Housing, Other Permanent Housing, Rapid Rehousing, and Street Outreach.

The years were; FY 2013, FY 2014, FY 2015, FY 2016

- Selected data points for the Data Quality Tab included:

Total number of persons served.

Total Leavers.

Destination error count.

System Performance Measurements (SysPM)

FY 2016 – SD, Statewide CoC Data Quality Findings

- There has been a general reduction in missing or don't know data in HMIS over the time period we examined but the percentage of these unknown or missing/refused data points remain significant for homelessness service system leavers
- There are concerns with HMIS individual files remaining open in HMIS from programs no longer actively using the HMIS
- A process is being considered to clean up the files from agencies that are longer active in HMIS
- The concern remains that the data quality in HMIS will need to be further addressed and the quality and accuracy of data in HMIS improved to meet the standards and expectations of HUD

DATA QUALITY

- 1.2. What is Data Quality?

Data quality is a term that refers to the reliability and validity of client level data collected in the HMIS. It is measured by the extent to which the client data in the system reflects actual information in the real world. With good data quality, the CoC can “tell the story” of the population experiencing homelessness.

The quality of data is determined by assessing certain characteristics such as timeliness, completeness, and accuracy.

2017 POINT-IN-TIME HOMELESS COUNT

- Summit packets include the 2017 PIT Count Press Release and PIT Count totals
- PIT efforts involved the collaboration of community agencies, homeless service providers, government, and volunteers
- Challenges of 2017 PIT Count included the severe winter weather of Jan 24 and the first time use of a mobile ap.
- SDHHC PIT Committee is organizing to address the PIT Count working together to further; efficiency, organization, training, awareness, and outreach
- It is anticipated that the PIT count will involve HMIS data more in the future and rely less upon current methods to conduct the count
